#### Section 1. Objective.

In adopting this policy, the company's stated objective is to provide communication platforms that maintain users' privacy while taking care not to contribute to the online exploitation of children.

#### Section 2. Prohibiting account registration by minors.

The company will not actively solicit account registrations from users under age 18, and will publish Terms of Service that prohibit users under 18 from registering accounts with any of our services. The company will suspend or close accounts found to be associated with individuals under 18.

#### **Section 3. Prohibiting Child Sexual Abuse Material.**

The company will publish Terms of Service that explicitly prohibit the following types of content from being posted or accessed using our network:

- Actual Child Sexual Abuse Material (CSAM) that is, still images, videos, or live streaming broadcasts of a child in a sexually explicit context, or engaging in sexually explicit acts
- Apparent CSAM sexually explicit illustrations juxtaposed with text labels, dialogue or other clear context which establishes that the person depicted is under age 18
- Photorealistically illustrated CSAM sexually explicit illustrations, usually generated with AI or 3D illustration software, that depict individuals who appear to be under age 18 in a sufficiently realistic manner that they could reasonably be mistaken for photographs

#### Section 4. Reporting Child Sexual Abuse Material.

When the company becomes aware of CSAM posted to our services that meets the industry classifications A1, A2, B1 or B2, the company will expeditiously report the content to the National Center for Missing and Exploited Children, as required by 18 USC 2258A. The company will also voluntarily disclose all personal data in its possession about the user who uploaded the content.

### Section 5. Participation by minors in public spaces operated by Company.

The company recognizes that, due to the nature of federated communication networks, it cannot generally prevent individuals under 18 from participating in public communities that it directly operates, provided those users have not directly registered an account with the company.

The company will actively moderate public communities that it directly operates (public Matrix rooms, Lemmy communities, BBS message boards, etc.), and will take action against users who appear to be grooming, extorting or trafficking individuals under age 18. Appropriate actions may include banning the user from our public

communities, reporting the user to a community moderation list, or—if the user is directly registered with the company—closing the user's account.

#### **Section 6. Moderation practices.**

The company will engage in active moderation of unencrypted media content publicly posted to its platforms. The company's moderation staff will follow the procedures documented in detail in the internal-use-only guide "Moderation Guidelines for Conversations and Media".

## Section 7. Company not to search users' private content.

Notwithstanding the previous sections of this policy, the company will not proactively scan or review content in which users have an expectation of privacy, for example: emails and their attachments, private file uploads, files stored in users' home directories on servers such that they are only accessible by that user, etc.

However, the company will act expeditiously to investigate reports associated with users' private content, if based on the report the company believes the content may be illegal.
